The seminar is based on the Treaty Handbook, which was developed and published by the Treaty Section of OLA. The Treaty Handbook is a practical guide to the depositary practice of the Secretary-General and the registration requirements of the Secretariat. It is designated to serve as a tool for Member States, secretariats of international organizations and legal practitioners.
